All river docks must be securely anchored to prevent them from becoming floating hazards during times of high river flows. All docks, hoists, slips and related structures shall be located, sized, configured, constructed and installed to limit their adverse impacts on the aquatic ecosystem. If your project involves dredging or the removal of rocks and sediment from the lake bottom, you may require a Work Permit from the Ministry of Natural Resources.
